



**Terms and conditions of using the public Wi-Fi network
on the premises of the Ignacy Łukasiewicz
Museum of Oil and Gas Industry in Bóbrka**

1. The Ignacy Łukasiewicz Museum of Oil and Gas Industry in Bóbrka (hereinafter referred to as the Museum) provides access to the resources of the Internet (Wi-Fi service) according to the principles specified in these Regulations.

2. By using the Wi-Fi network, the user declares that he/she is familiar with the content of these Regulations and undertakes to comply with them.

3. The Wi-Fi service is available free of charge:

- a) for all persons staying on the Museum premises, during its opening hours,
- b) for private purposes, not related to conducting business activity (economic, professional).

4. The shared hotspot network shall provide the greatest possible comfort in the use of Internet resources, depending on the transmission load of the users. The device is automatically disconnected from the access point if:

- a) it exceeds the 512 MB transfer barrier during an established session,
- b) is inactive for 5 minutes,
- c) the time of use exceeds 2 hours.

The user can then reconnect to the network.

5. The Museum does not guarantee uninterrupted or unimpeded availability of the Wi-Fi service. The service may be temporarily unavailable at any time, and as a result of technical conditions or other causes affecting the quality of data transmission, the speed of transmission may be reduced, so that delays may occur in the actual transfer of data to and from the user's mobile device.

6. The service is used by connecting a mobile device to the wireless network available on the Museum premises. Users shall ensure on their own and at their own expense that their mobile devices can be used, that they are protected against unauthorised access by third parties, that they are equipped with appropriate anti-virus software and that the devices are compatible with the Wi-Fi service.

7. Users shall take appropriate network security precautions, such as using strong passwords that comply with the rules as to their complexity and avoiding untrusted websites.

8. In order to connect the device to a wireless network, the mobile device must be equipped with a Wi-Fi radio module, compliant with the 802.11b/g/n/a/ac/ax standard, operating in an acceptable frequency band (2.4 GHz / 5 GHz).

9. The Wi-Fi service allows the use of HTTP (port 80) and HTTPS (port 443) via web browsers and mobile applications. For security reasons and limited network capacity, the availability of all network services is not guaranteed.

10. Records of network traffic using the Wi-Fi service are stored on an ongoing basis (e.g. allocation of local IP addresses) and requested external traffic (e.g. DNS queries) is monitored.

11. The Museum does not provide technical support to users on the configuration of mobile devices and the use of the Wi-Fi service. The service provider is not responsible for any loss, damage or problems resulting from the use of the Wi-Fi network.

12. Users are obliged to use the Wi-Fi service in a manner that complies with the law and good morals and does not pose a security risk to the network.

13. The User may be deprived of the possibility to use the Wi-Fi service in the event of actions incompatible with these Regulations, and in particular in the event of:

- a) attempting to access network resources to which the user is not entitled,
- b) an attempt to bypass security measures applied to wireless access (i.e. a change of the IP address assigned by the DHCP server, use of tunnels, etc.),
- c) sharing and downloading copyrighted materials (software, films, music etc.) from the network without the consent of the authors,
- d) use P2P applications,
- e) to further share the signal through the use of repeaters, routers, proxies, etc.,
- f) running service servers on devices connected to hotspots,
- g) other activities that may be considered potentially dangerous to the operation of the network and the users on it.

14. The Museum is liable for damages caused to users on general terms.

15. Any irregularities in the functioning of the Wi-Fi service can be reported using the contact form available on the Museum website - bobrka.pl.

16. These Regulations may be amended at any time.

Commencement of use of the Wi-Fi service requires prior acceptance of these Regulations.
